TOURNAMENT POLICIES

We (herein referred as “The Event Group”) agree to the following terms and conditions set forth and release Candler Hills Golf Club (herein referred as “The Golf Club”) of all claims and liabilities.

- 1. Guarantee:** If no guarantee is received WITHIN 72 HOURS of the event, The Golf Club will prepare and charge for the number of persons estimated from the contract.
- 2. Charges:** All tournament charges must be signed by the designated representative at the completion of each tournament. Any discrepancies in counts or charges should be identified and resolved at that time.
- 3. Gratuities:** All tournaments are subject to a minimum \$2.00 service (gratuity) per person charge and applicable state and local sales taxes.
- 4. Deposits & Refunds:** All or a portion of any deposit paid will be refunded, in good faith, dependent on The Golf Club’s ability to recoup the lost revenue. For groups over 16, the cancellation policy deposit will be returned as follows:

60 - 31 DAYS, 80% REFUNDABLE

30 - 15 DAYS, 60% REFUNDABLE

14 – 7 DAYS, 40% REFUNDABLE

It will be at the discretion of The Golf Club whether to refund any amount of a deposit if cancellation notification is received less than two (2) days prior to the scheduled function. It is solely at The Golf Club’s discretion whether non-refunded deposit amounts will be credited toward a future event.

- 5. Payments:** Payment in full is required prior to all tournaments unless prior credit arrangements have been established with The Golf Club.
- 6. Additional Staffing:** If a change from the original set-up is requested on the day of the function, a labor charge will be added to the check. If The Event Group requires more staffing than normally required; a rate of \$50.00 per hour, per employee will be added to the check. Normal staffing needs are: golf operations 4 employees per 100 players, food and beverage servers 1 per 24 diners with plated meals, 1 per 40 diners with buffet meals.
- 7. Final Counts:** Final preparations should be submitted two weeks prior to the function to insure the availability of the desired items.
- 8. No Outside Food & Beverage:** No food or beverage of any kind will be permitted to be brought onto the property by any member, guest or tournament participant.
- 9. Security Personnel:** The Golf Club will request that the customer obtain and pay for bonded security personnel when valuable merchandise or exhibits are displayed or held overnight in The Golf Club.

10. **Prior arrangements:** The customer is responsible for the arrangements and all expenses of shipping materials, merchandise, exhibits, or any other items to and from The Golf Club. The Golf Club must be notified in advance of shipping arrangements to insure proper acceptance of these items upon arrival.
11. **The Golf Club is not responsible:** for damage to or loss of any items left in The Golf Club prior to or following any tournament.
12. **Damaged caused by Event participants:** The Event Group is responsible and shall reimburse The Golf Club for any damage, loss or liability incurred by The Golf Club by any of The Event Group's guests or any persons or organizations contracted by The Event Group to provide any service or goods before, during and after the tournament.
13. **Prior approval:** Any items (i.e. banners, tee or green sponsor boards, tents, directions etc.) to be put anywhere on property must be approved by The Golf Club.
14. **Non-Performance:** The Golf Club shall not be liable for non-performance of this contract when such non-performance is attributable to labor troubles, disputes or strikes, accidents, government (Federal, State and Municipal) regulations of or restrictions upon travel or transportation, non-availability of food, beverage, or supplies, riots, national emergencies, acts of God and other causes whether enumerated herein or not, which are beyond the reasonable control of The Golf Club, preventing or interfering with The Golf Club's performance.
15. **Food & Beverage Policy:** Standard policy is to keep any food/beverage items available until departure time. **Excess food and beverage cannot be carried out of The Golf Club.**
16. **Terminology:** Where appropriate, the term "Club" shall refer to Candler Hills Golf Club, its Officers, Directors, Agents, Employees and Independent Contractors and is not intended necessarily to refer to the golf course or club building where the function is held.
17. **Dress Code:** Appropriate dress is required. Tournament Planners/Coordinators are responsible for the appropriate dress of all tournament guests. Shirts with collars and sleeves and pants or walking shorts must be worn at all times. **NO JEANS, CUT OFFS, T-SHIRTS, TANK TOPS OR SWEAT PANTS ARE PERMITTED.**
18. **Slow Play:** All groups must stay in pace of play with the group ahead. Any group falling behind will be asked to advance to the proper position. In the event of continual slow play they may be asked to leave the course with no refund.
19. **Rain Out:** If it should occur that the event is rained out, rain checks will be given to all players, with a one year expiration date. Rain dates **will not** be assigned prior to the event.
